BIOGRAPHY

Having worked on every major lawsuit concerning ICT (Information and Communications Technology) patents in Brazil, Rodolfo Barreto has gained one-of-a-kind expertise in high-stakes patent litigation and cross-border disputes. He is also prominent in legal and administrative matters involving antitrust and Standard-Essential Patents (SEPs). Mr. Barreto is the go-to litigator when key intellectual property assets are involved.
