BIOGRAPHY

He has established a reputation as a trial and appellate practice specialist, focusing on preliminary and permanent injunctions and monetization (damages and licensing), advising clients primarily on patent, trade secrets, unfair competition and regulatory data exclusivity, government procurement, food and drug, and regulatory of telecommunications and internet.

Otto was responsible for the first Brazilian nationwide adjudication campaign for patent monetization (optical CD-R disks). Before joining private practice, Mr. Licks worked as a UN/PINUD consultant for the Brazilian State Department, during the implementation of the WTO Agreements. He has been the first chair in over 100 cases, from TROs and ex-parte injunctions up to leading cases before the Brazilian Supreme Court, establishing a reputation as a trial and appellate practice specialist, with an outstanding track record in obtaining, defending, and enforcing preliminary and permanent injunctions.
